

## CNSW FAIR PLAY DECLARATION

### Keeping cricket in New South Wales fair, safe, inclusive and welcoming

By signing this declaration, BlowFly Cricket (*print name of Cricket Organisation*) acknowledges and agrees to be bound by, comply with and to take active steps to implement the Cricket NSW Integrity Framework (**Integrity Framework**) within its organisation and to promote an environment that is fair, safe, inclusive and welcoming. The Integrity Framework is comprised of the Integrity Policies which include:

- CNSW Complaints and Dispute Resolution Policy;
- CNSW Code of Conduct – as set out in clause 5 of the NSWCA By-Laws;
- CNSW Member Protection Policy;
- CNSW Anti-Corruption Policy;
- Cricket Australia Anti-Doping Code;
- Cricket Australia Illicit Substances Rule; and
- [CNSW Safeguarding Children Young People Policy](#) and **Cricket Australia’s Looking After our Kids Code of Behaviour (Child Safe Policies)**.

The organisation also acknowledges its obligation to comply with the legislated [New South Wales Child Safe Standards](#) (from 1 February 2023):

- 1) Child safety is embedded in organisational leadership, governance and culture;
- 2) Children participate in decisions affecting them and are taken seriously;
- 3) Families and communities are informed and involved;
- 4) Equity is upheld and diversity is taken into account;
- 5) People working with children are suitable and supported;
- 6) Processes to respond to complaints of child abuse are child focused;
- 7) Staff are equipped with the knowledge, skills and awareness to keep children safe through continual education and training;
- 8) Physical and online environments minimise the opportunity for abuse to occur;
- 9) Implementation of the Child Safe Standards is continuously reviewed and improved;
- 10) Policies and procedures document how the organisation is child safe.

**(Child Safe Standards)**

To meet the Child Safe Standards and implement the Integrity Framework, the Cricket Organisation will:

#### 1) **Commit:**

- a. Discuss & sign this declaration as a committee to formally **endorse** our CNSW Integrity Framework and record the endorsement in the minutes.
- b. **Promote** this declaration widely through the club network, for example, by adding this signed declaration to our website / social media, sending to our email database, displaying in clubrooms etc.
- c. **Appoint** a Fair Play Officer (and/or Child Safety Officer) and promote their details to families / members of the Club.

- 2) **Implement** – Regular discussion occurs and actions are taken to meet the Child Safe Standards (see [Cricket Australia’s Child Safety](#) and [Cricket NSW’s Working With Children](#) and [Child Safeguarding](#) webpages and for support resources).

- 3) **Report** - reporting breaches of Integrity Policies without delay to [Cricket NSW's Integrity Unit](#).
- 4) **Learn & Embed** - continuously learn to build a welcoming, fair, safe and inclusive culture in our organisation through:
  - a. discussions with Children & Young People, families and adults involved in our organisation;
  - b. education through awareness workshops and resources provided; and
  - c. regular committee and broader reviews of our policies, procedures and practices.
